



Finance Committee Update

Fiscal Year 2018 Highlights to Date

- All 56 states and territories accepted **State Plans**
 - Enhances integration across the network
 - Sustainability payments to FirstNet; \$5.5 billion in payments to AT&T for network deployment
- **Nationwide advocacy/outreach** with public safety and the FirstNet Public Safety Advisory Committee (PSAC)
- Launched **dedicated core**
 - Dedicated public safety network and Security Operations Center in place
- **Cleared all audits** and Inspector General (IG) reports
 - Fifth consecutive clean financial audit, annual legislative reports, three IG audits
- **Continued financial stewardship**, meeting financial requirements while running under budget
- Evolved organization to **oversight and partnership**

FY 2019 Executive Summary

- FY 2019 Operational budget request is \$81 million on an obligations basis
- FY 2019 Reserve Allocation request is \$81 million
- FY 2019 Reinvestment in Network Enhancements for public safety request is \$78 million on an obligations basis, plus any additional budgetary sources derived in FY2019
- FY 2019 Budget Priorities
 - Oversight of Nationwide Public Safety Network buildout
 - Introduction of Independent Validation and Verification of public safety network coverage
 - Continued resources necessary to achieve FY 2019 goals, meet FirstNet mission







FY 2019 Milestones



Finance Committee Resolution 20 – FY 2019 Budget

1. Recommends the Board authorize senior leadership to **allocate the FY 2019 Budget of \$240M in revenues into 3 categories:**
 - 1) Operational budget of \$81 million on an obligations basis (plus a 10% re-allocation allowance),
 - 2) Reserve of \$81 million (equal to 1 year of Operations budget), and
 - 3) Future reinvestment option in Network Enhancements of \$78 million on an obligations basis, plus any additional budgetary sources derived in FY2019.
2. Recommends the Board authorize senior leadership to **enter into the necessary agreements** to meet FY 2019 milestones.
3. Recommends the Board **approve the proposed FY 2019 Operational budget** of \$81 million on an obligations basis.


Board Resolution 91 – FY 2019 Budget

Technology Committee Update

Band 14 Spectrum Management Program – All Spectrum Cleared

- Band 14 Spectrum Relocation Federal Grant Program
 - \$40M budget initially established in 2015
 - Ultimately, awards to 4 state and 7 municipal public safety entities totaled \$27M; grants covered all costs related to relocating from Band 14
 - Band 14 spectrum clearance was finished on 31 July 2018, under budget with total grants funds used of \$23M
 - The \$4M in recouped grant funds will be available for NPSBN prioritized initiatives
 - DOC Office of Inspector General audit of grant program was completed with no stated issues
- Collaboration with the FCC
 - Assessment and disposition of FCC commercial entity applications to use Band 14 on not-to-interfere basis for research, testing, and development
- Collaboration with NTIA Office of Spectrum Management (OSM) and other federal agencies
 - Assessment and disposition of 40+ legacy federal Band 14 use cases



Network Operations Highlights

Highlights

- As of July, nearly 1,500 public safety entities in 52 states/territories adopted FirstNet
 - These FirstNet User accounts include 110,000+ connections using FirstNet-branded public safety services
- All FY18 deliverables required by contract have been submitted to date
- Subscriber-paid offering launched in May
 - FirstNet services available to public safety volunteers/career public safety individuals who don't get agency-issued devices/services
- Task Order 3 Core Design Review finalized late May
- First Task Order 4 RAN Requirements Traceability Matrix (RTM) finalized in June

Next steps

- Ongoing validation and verification of the Core and network and security operations

Task Order 4 Overview

About the Task Order

Requires AT&T to execute state/territory Radio Access Networks (RANs), including:

- Build, operate, maintain, improve RAN execution for each state/territory's Plan of Record (POR)
- Provide Band 14 and non-Band 14 coverage and capacity that meets or exceeds targets in the state/territory POR and each IOC
- Report on any state-specific commitments as identified in state consultation letters
- Evolve network as features/technologies become available to better serve public safety


Progress

- Accelerated deployment milestones under IOC-2
- Validating Band 14 site build-out
- Accepted 11,207 National Environmental Protection Act requests
 - Required before Band 14 site installation
- Establishing coverage verification approach and methodology
