Public Safety Advisory Committee (PSAC) and Association Consultation




- Focused engagements on Request for Information/draft Statement of Objectives (RFI/SOO), First Public Notice, and consultation results
- Conducted February PSAC webinar and three monthly PSAC Executive Committee conference calls
- Public safety association board meetings
 - Eight presentations to date by Swenson and Johnson
 - Five more scheduled presentations
 - Stanek, Burbank, and McGinnis involved in the meetings with their associations
- Association staff briefings planned for spring and fall 2015

Tribal Working Group Update



- Working Group conference call held in January 2015 and an in person meeting in February 2015
- Working Group recommendations included:
 - Expanding membership to include a large, multi-state tribe
 - Listing of targeted public events at which to offer presentations
 - Undertaking culturally aligned multimedia outreach campaign
 - Offering to engage with state and territory single points of contact (SPOCs) during April 2015 gathering



- Conducted Federal Consultation Kickoff Summit January 21
 - Established a baseline understanding of FirstNet activities among federal agencies
 - Clarified designated Agency Points of Contact
 - Distributed Initial Preparation Checklists to Agency Points of Contact
- Provided FirstNet updates through outreach and consultation meetings with federal agencies
 - Department of Justice
 - Department of the Interior
 - Health and Human Services
 - Department of Agriculture
- Begin federal agency initial consultation meetings
- Determine format and delivery of federal user data as it relates to state plans

State Outreach and Consultation Updates



- Held in-person meeting, webinars, and regional calls to increase opportunities for stakeholders to provide early feedback in processes
 - February Data Collection Preview meetings involved 54 states and territories
 - February regional calls included over 100 participants
- In coordination with the State and Local Implementation Grant Program (SLIGP) team, will host 2015 SPOC Meeting April 14-15
- Expected outcomes include:
 - Informed and up-to-speed state and territory representatives
 - Better informed FirstNet planning activities based on input received from SPOCs
 - State and territory representatives are engaged and included in FirstNet planning
 - Shared successes and lessons learned for more successful FirstNet planning activities




Progress to Date: Consultation with Over 1,000 State Attendees




Progress to Date: Use Cases and Applications






